As you know, all signatory contractors are required to submit monthly reports and contributions to the Fox Valley Laborers Benefit Funds. Contractors who fail to submit their reports and payments in a timely manner are considered delinquent.

The Funds pursue all delinquencies in accordance with established procedures. A contractor's delinquencies cause the Funds to expend additional time and resources to collect the delinquent reports and payments. More importantly, unpaid contributions create hardships for the contractor's employees who do not get the eligibility they need for benefits because their employer failed to timely report their hours or pay their contributions.

The Trustees of the Funds have also considered the problems that delinquent contractors cause for other contractors who pay their contributions on a timely basis. In order to help contractors that may be affected by delinquencies of their subcontractors, the Trustees have decided that it is in the best interests of the Funds and their participants to implement a policy whereby all signatory contractors receive notification of those signatory contractors that are shown to be delinquent to the Funds for at least 60 days, according to the Funds' most recent records of reports, audits and pending cases. As a result, we will begin sending all signatory contractors a delinquency list on a monthly basis. Although the Funds will make every effort to ensure the accuracy of the delinquency list, you should keep in mind that, while the list may be accurate at the time it is initially distributed, circumstances may change or payment may be made which will not be reflected until the next list is distributed.

If you are concerned with the possible delinquency of any contractor on the list, you should contact the listed contractor to see if a delinquency really exists and contact the Funds for verification if the contractor represents that no delinquencies exist. If you are a contractor who is shown as delinquent on the list and you believe that you have been improperly or mistakenly categorized as delinquent, you should contact the Fox Valley Fund Office for clarification at 847-742-0900.
